Dikgatlong Municipality hereby invites suitably prospective service providers to quote for supply, delivery and offloading of road maintenance material. **Sealed** Price quotations clearly marked “**RFQ29/2023/24 SUPPLY, DELIVERY AND OFFLOADING OF ROAD MAINTENANCE MATERIAL**” endorsed on the envelope” must be submitted to the Dikgatlong Local Municipality, 33 Campbell Street, Barkly West, 8375. Bids **must** reach the municipality before **12h00 on Friday the 24th of May 2024**.

BACKGROUND AND SPECIFICATIONS/ SCOPE OF WORK

The road maintenance team needs material for maintenance of our road network. Unfortunately, there is not enough material available for the maintenance needs. The numbers of bags of cold asphalt in stores are also low and we therefore we need to replenish our stock. Other material required include crusher dust, cement and SS60 bitumen.

The material to be procured must comply to at least the following specification:

a) Cold Asphalt Mix:

- The product must be carbon-based (must contain coal shale and bitumen).
- Packaging: Must be supplied in 25kg durable sealed weatherproof plastic bags.
- Shelf life: In Stores – 1 year, Outside – 3 months.
- Priming of exposed surface (base): No prime coat needed.
- No heating required for application.
- Installation to be able in wet or dry conditions as well as cold or hot weather.
- Drying time for drying: 2 hours.
- The product that is easy to apply and should enable labour intensity.

b) PPC Cement

- The cement must comply with the 32,5 R strength class of SANS 50197-1 for common cements.
- Packaging: 50 kg Bags

c) Rock Dust / Crusher Dust

- Crusher dust is a compact, fine rock particle aggregate that's been excavated and refined in a quarry. It is a grey, finely ground powder or dust-like aggregate.

d) SS 60 Bitumen

- SS 60 stable grade conforms to the SANS 4001-BT3 specification for anionic bitumen road emulsions
- Packaging: New steel drums, reconditioned steel drums or eco-friendly poly bags. Weatherproof packaging.

All quotes will be adjudicated and awarded in terms of the Dikgatlong Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.
3. Quotes must be valid for a period of 30 days
- 4. Suppliers must submit their quotes with the following documentation and or information:**
 - 4.1 A valid original Tax Clearance certificate or a valid tax pin.
 - 4.2 A certificate certifying that the bidder has no undisputed commitments for Municipal services**

towards a municipality or service provider i.r.o. payments which are overdue more than 90 days; if the bidder is the lessee a valid lease agreement together with the municipal account of the landlord; or a letter from tribal authority if the service provider operates in rural area.

- 4.3. Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies or valid affidavit order to claim HDI points.
- 4.4. MBD 4, 6.1, 8 and 9 must be fully completed and submitted together with a quotation.
- 4.5. Bidders must be registered on the Central Supplier Data Base.
- 4.6. The tender will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals (HDI and Locality) as illustrated below.

1. GENERAL CONDITIONS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOMEGENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

- Ps = Points scored for price of tender under consideration
Pt = Price of tender under consideration
Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
