Dikgatlong Municipality hereby invites suitably prospective service providers to quote for extending of low voltage overhead power line in Longlands. Sealed Price quotations clearly marked "**RFQ23/2024/25 EXTENDING OF LOW VOLTAGE OVERHEAD POWER LINE IN LONGLANDS**" clearly endorsed on the envelope must be submitted to the Dikgatlong Local Municipality, 33 Campbell Street, Barkly West, 8375. Bids **must** reach the municipality before **12h00 on Friday the 31st of January 2025**.

BACKGROUND

The Municipality is currently building a water supply mini substation, which will be using borehole pump and motor, for. The distribution board to be connected, an LV power line needs to be constructed. A close by point of supply is approximately 500m away. A new LV overhead power line to be built, will be joint to an existing LV Overhead powerline (point of supply).

All quotes will be adjudicated and awarded in terms of the Dikgatlong Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.

3. Quotes must be valid for a period of 30 days

4. Suppliers must submit their quotes with the following documentation and or information:

4.1 A valid original Tax Clearance certificate or a valid tax pin.

4.2 A certificate certifying that the bidder has no undisputed commitments for Municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 90 days; if the bidder is the lessee a valid lease agreement together with the municipal account of the landlord; or a letter from tribal authority if the service provider operates in rural area.

4.3 MBD 4, 6.1, 8 and 9 must be fully completed and submitted together with a quotation.

4.4 Bidders must be registered on the Central Supplier Data Base.

4.5 The tender will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals (Locality and HDI) as illustrated below
